The regulation is found at 24 CFR 570.207(b)(1)(i) (see below).

Construction equipment. *The purchase of construction equipment is ineligible, but compensation for the use of such equipment through leasing or depreciation pursuant to [2 CFR part 200, subpart E](#), as applicable for an otherwise eligible activity is an eligible use of CDBG funds. However, the purchase of construction equipment for use as part of a solid waste disposal facility is eligible under [§ 570.201\(c\)](#).*
