Royal American Construction is well known to the City and Mott MacDonald. Royal American Construction was found to be competent, responsible and the lowest bidder. Mott MacDonald recommends award to Royal American Construction Company, Inc. based on the Commission and funding agency approval, as well as the availability of funds. If for any reason a contract cannot be negotiated with Royal American Construction, we recommend award to the next lowest bidder, Mainline Construction, LLC.

We request the Commission approve this project for the Bid amount of \$2,027,392.01, which includes CDBG-DR funded improvements (\$1,813,940.31) and Non-CDBG funded improvements (\$213,451.70). We also request to preauthorize the City Manager, Jonathan Hayes, to execute any Change Orders up to a cumulative amount of \$101,369.60 (5% of contract amount), resulting in a total project amount of \$2,128,761.61. Any change order value which exceeds this amount would be brought back to the commission for approval.
