PARK RULES:

1. Banners must be within 32 square feet
2. Use string and tape for decorating – no nails may be used. Clean up prior to rental/use.
3. No alcoholic beverages allowed in park.
4. Amplified music/sound systems must be kept within 70 decibels.
5. No cooking permitted.
6. No vendors allowed.
7. Tents and their location must be approved prior to event.
8. Tents over 100 square feet will need zoning approval and a permit.
9. \$25.00 Park Permit Fee for each four-hour event is non-refundable and required to reserve the park. Fee is for permitting purposes only, the park will remain open for public use.
10. \$250.00 Refundable Damage/Clean-up Deposit is required to reserve the park. Deposit to be returned upon satisfactory inspection of property after event/rental.

LICENSES, PERMITS, and COPYRIGHTS: The user shall obtain and pay for all licenses and permits necessary to conduct its operations or events as specified in this application. The user will assume all costs arising from the use of patented, trademarked, franchised, or copyrighted music, materials, devices, processes, or dramatic rights used or incorporate in the event. The user agrees to indemnify, defend and hold harmless the City of Panama City from any and all costs, including legal fees, which might arise from any violation of this provision by the user.

INDEMNIFICATION: User agrees to indemnify fully and save and hold harmless the City of Panama City, its officers, employees and agents, against all damage, claims, liabilities and causes of action of every kind and nature, to the extent they are caused by the conduct of the user, its visitors, agents or employees. City shall give users prompt and reasonable notice of any such claims or actions and user shall have the right to investigate, compromise and defend the same to the extend of sponsor's own interest.

WAIVER OF ALL CLAIMS: City and its agents, employees and contractors shall not be liable for, and user hereby releases all claims for damage to or loss of personal property sustained by user or any person claiming through user resulting from any fire, accident, occurrence, theft, or condition in or upon the City premises/facility or which they shall be a part of, or if adjoining or contiguous property or buildings, provided same are not due to negligence of City, its agents, or employees.
