

## ***Notice of City of Panama City Community Redevelopment Agency Meetings***

**In compliance with F.S. §189.015, this notice serves to provide the meeting schedule for the City of Panama City Community Redevelopment Agency (CRA) for the year 2026.**

**The CRA will also host monthly non-voting virtual workshops to be held on the third Wednesday of each month at 4:30pm, CT.
